With all the positive accomplishments related to our SIG, we need to keep an ever-present eye on the


political forces and the implications of high stakes testing on the middle school movement.

UPDATE ON MIDDLE LEVEL RESEARCH ORGANIZATION NETWORK (MLRON)

The Middle Level Research Organization Network (MLRON) held its second annual meeting on Friday, November 2, 2001, in Washington, DC, during the National Middle School Association conference. Approximately 35 representatives of the three organizations that comprise MLRON attended the meeting. MLRON includes all members of the American Educational Research Association's Special Interest Group on Research in Middle Level Education (RMLE SIG), the National Association for Professors of Middle Level Education (NaPOMLE), and the National Middle School Association's Research Committee.

Five of the six MLRON committees provided brief updates at the meeting. Summaries of those reports appear below.

1. Mission and Organization Committee (chair: Gayle Davis, The University of Georgia, gdavis@coe.uga.edu). The Mission and Organization Committee presented the revised version of the MLRON mission statement and distributed approval forms seeking endorsement or comment. The latest version of the mission statement states:

The mission of the Middle Level Research Organization Network (MLRON) is to encourage, sponsor, and disseminate research that improves the quality of schooling for young adolescents. MLRON is comprised of the National Middle School Association's Research Committee, the American Educational Research Association's Special Interest Group on Research in Middle Level Education, and the National Association of Professors of Middle Level Education.

To accomplish this mission, MLRON:

*Encourages collaborative, multidisciplinary research sponsors networking among organizations that promote and/or conduct research related to young adolescents; *Disseminates research about young adolescents to practitioners, parents, and policymakers at local, state, and national levels. The Mission and Organization Committee collected feed-back on this draft and will present a final version for endorsement to the members of all three groups involved in MLRON in the coming months.

The Committee also led a discussion of their proposal for developing a governance structure for MLRON. The proposal included the following elements:

Establish a MLRON Coordinating Council. The Council would include six representatives, two from each of the three organizations involved in MLRON. One of the two representatives from each organization should be from that organization's leadership, either appointed, elected, or active.

Each member of the Coordinating Council would serve two-year terms, with odd and even-year appointments. One half of the initial group would serve one extra year to get the rotation of appointments started.

The Coordining Council would meet quarterly, either by conference call or in person.

Each MLRON standing committee (currently five) would have a liaison on the Coordinating Council. The liaison would not necessarily serve on the standing committee, but would be responsible for staying in touch with the committee chair and communicating the work and requests of the standing committee to the Coordinating Council.

Based on the discussion at the MLRON meeting, Gayle Davis (NMSA Research Committee chair), Barbara Whinery (RMLE SIG President), and Deborah Thomas (NaPOMLE President) will take the lead in securing endorsement of the revised MLRON mission statement and drafting a letter to the leadership of the three organizations to establish a MLRON Coordinating Council.


2. Communications Co mittee (co-chairs: Micki M. Caskey, Portland State University, caskeym@pdx.edu; Kim K. Ruebel, Georgia Southern University, kruebel@gasou.edu). The Communications Committee presented the options they had developed for improving and increasing communication among the three groups involved in MLRON. Their recommendations and next steps include:

- Supporting the efforts of David Quinn to establish, host, and maintain the MLRON website. Contacting
 our respective universities and colleges about access and costs related to an electronic bulletin board, and
 then use this information to determine whether a listsery or bulletin board is a better option.
- 3. Research on Student Achievement Committee (chair: Joanne Arhar, Kent State University, jarhar@kent.edu) The Research on Student Achievement Committee is exploring the various ways student achievement and learning have been constructed and assessed within both the measurement and constructivist paradigms both nationally and internationally. Currently, each committee member, in collaboration with another researcher, is developing a literature review/background paper on various issues related to how achievement and learning have been constructed and assessed. The Committee has also begun developing research questions and will, hopefully, be seeking funding to support research to address those questions. The Committee also hopes to develop policy statements about middle level student achievement and learning that reflect the vision statement of the National Forum to Accelerate Middle Grades Reform (www.mgforum.org). The National Forum's vision states that education for young adolescents should be academically challenging, developmentally responsive and socially equitable.
- 4. Identifying Research Interests and Projects Committee (chair: Vincent Anfara, University of Tennessee. vanfara@utk.edu). This Committee presented options and recommendations for identifying MLRON members' research interests and current or past research projects. Their first and preferred option was creating a MLRON website that would be linked to the NMSA, RMLE-SIG, and NaPOMLE websites. As noted above, David Quinn has already begun developing a MLRON website. This website would allow middle level researchers to create profiles that would include contact information, a selected list of recent and/or important publications, and current projects. Please note that this type of profile is much like the one that can be created on the "Community of Science" website. See http://www.cos.com for a better understanding of what is meant here. Researchers would be able to update their information whenever they choose. The website and profile opportunity would be advertised in the Middle School Journal, Schools in The Middle, NASSP Bulletin and on NMSA, SIG, and NaPOLME's websites, newsletters, etc. The Committee also pointed out that David Hough recently mailed out a survey pertaining to NMSA's Research Agenda for the 21st Century. Information from this survey could be compiled and a report written on what response this research agenda has received. Finally, this Committee suggested that a small subcommittee be created to review NMSA and AERA program books from the past four years and analyze what has been researched and presented. Additionally, electronic searches could be conducted in such databases as Dissertation Abstracts International, ERIC, etc. The Committee will be following up on the website/profile option by working with David Quinn, NMSA, the RMLE-SIG, and NaPOMLE to develop the profile form, advertise the website and the profile opportunity through various electronic and paper publications, and encourage members of the three organizations to submit a profile. Please contact Vincent Anfara (vanfara@utk.edu) if you would like to participate in this committee.
- 5. Recognizing Distinguished Research Committee (chair: George White, Lehigh University gpw1@lehigh.edu) This Committee had only convened once, by conference call, shortly before the NMSA conference and had not yet developed options or recommendations. The chair, George White, is seeking additional members who can help to:
- Develop options for recognizing distinguished research, e.g., kinds of recognition and criteria;
- Describe the implications for each option regarding budget, timing, staff needed both initially
 and for maintenance of an ongoing process (e.g., annual award process, a standing recognition
 committee)
- Assist in drafting a brief progress report outlining the options and the Committee's recommendations.
 Please contact George White (gpw1@lehigh.edu) if you would like to participate in this committee.

Finally, based on the discussion in Washington, DC, Barbara Whinery is currently compiling and prioritizing the next steps the meeting participants and MLRON Committees suggested. A report on those next steps will appear in the next RMLE-SIG newsletter. In the meantime, please contact any of the MLRON Committee chairs (contact information above) if you are interested in becoming involved in MLRON's important work to encourage and disseminate multidisciplinary research and to sponsor networking among researchers and organizations involved in middle grades education.



Minutes from the November Research in Middle Level Education SIG

- Our most recent SIG Business Meeting was held in November at the Hyatt Hotel in Washington, DC during the NMSA conference. SIG President, Barb Whinery, welcomed the group and gave an overview of the current year. Vince Anfara, Program Chair and President-Elect distributed Research in Middle Level SIG CD holders to audience members.
- Treasurer, Nancy Mizelle, discussed membership issues. When people renew their AERA membership, they can pay SIG dues, but the information is not automatically forwarded to Nancy. When you renew using the AERA form, it would be helpful if you would let Nancy know that you have paid your SIG dues. (nmizelle@mail.gcsu.edu)
- 3. Vince Anfara discussed that the SIG had enough members for two paper sessions and paper discussions (formerly called roundtables) at the upcoming AERA meeting in New Orleans. The SIG still needs to encourage more people to join and to encourage more people to submit proposals to the SIG. Vince suggested that the SIG develop a recruitment plan and share the benefits of joining the SIG which include: the listserv, the handbook, publication opportunities, the newsletter, and being among advocates in middle level education. Vince also suggested that the SIG consider changing its name from Research in Middle Level Education SIG to Middle Level Research SIG. Some people have been unable to locate the SIG when they look under middle schools. The SIG will continue this discussion.
- 4. Dick Lipka is inviting book publishers to the SIG business meeting at AERA in New Orleans. Dick is widely published and his bringing publishers to our meeting is a good way to hear what publishers are looking for as well as an opportunity to discuss your research interests with them.
- 5. Kim Hartman, Secretary, announced the election results and noted that there was a 99% return rate on ballots. Elected to the SIG Advisory Board were: Joann Arhar, Gayle Davis, Steve Mertens, and Kathleen Roney. Congratulations!
- 6. Nora Alder, Vice President, discussed the \$100.00 scholarship for a graduate student to attend AERA. Due to a glitch, AERA did not have the information on their books; however, this problem has been resolved. Providing this stipend is a way to recognize promising young researchers and assist graduate students presenting at AERA. SIG members discussed increasing the stipend to \$200
- 7. Since the SIG is not an affiliate of NMSA, our meetings are not listed in the NMSA Program. David Hough will take care of having our meetings listed in the program for the 2002 NMSA Conference. David is also conducting a survey on middle level education. Look for the upcoming results
- 8. Kathleen Brown and Kathleen Malu, newsletter co-editors, encouraged people to submit materials to the newsletter. They are open to a variety of middle level issues and noted that there is no page limit on submissions. The newsletter is published in February, May and October.
- Micki Caskey announced that the new website (www.rmle.pdx.edu) is up and ready. Thank you
 Micki! You can email Micki at (caskeym@pdx.edu) and send information regarding your research,
 articles, etc.
- Brenda LeTendre has volunteered to publish the SIG proceedings. These can be listed as referee publications.
- Vince Anfara announced that the Handbook of Research in Middle Level Education has been ordered and that NASSP is supporting this effort. Currently, Vince is working on a 2nd volume, Middle Level Curriculum, Instruction, and Assessment. Vince welcomes your submissions.
- 12. The SIG has plans to hold a conference-within-a conference during an upcoming AERA meeting, possibly 2003 or 2004. This conference will be a way for middle level people to network and discuss middle level issues. Dick Lipka is interested in helping with the conference, but not taking the lead. Dick will mentor a junior faculty. This is a wonderful opportunity for a junior faculty and/or perhaps a team of people who would be interested in working on the conference. If you are interested, please contact one of the officers or Dick.
- 13. The SIG discussed the possibility of having a joint MLRON, NMSA, NaPOMLE, and RMLE SIG meeting. The purpose of this meeting would be to share ideas and purposes of each group and to network with others interested in the various aspects of middle level education.



AERA/SIG Research in Middle Level Education By-Laws:

Proposed Changes

Article I: Name and Governing Authority

Section 1. The special interest group shall be known as the SIG: Research in Middle Level Education. Proposed Change: The special interest group shall be known as the SIG: Middle Level Education Research. Rationale: Persons interested in research in middle level education would more easily identify the SIG. Section 3. The by-laws of the SIG are subject to being superseded by the by-laws and constitution of AERA. Proposed Change: The by-laws of the SIG are subject to the by-laws and constitution of AERA. Rationale: Clearer statement of the relationship of SIG by-laws to the AREA by-laws and constitution.

Article III: Membership

<u>Section 1</u>. Membership in the SIG, including the right to vote and hold elective office, shall be open to any person whose dues have been paid for the current year. **Proposed Change**: Membership in the SIG, including the right to vote and hold office, shall be open to any person whose AERA and SIG dues have been paid for the current year. **Rationale**: SIG officers should provide leadership and support for SIG presentation opportunities associated with memberships in both organizations. The AERA Handbook of policies and Procedures for Special Interest Groups (2001-2002) specifies that the SIG President and Vice President (Program Chair) hold current memberships in AERA and the SIG.

Section 2. The membership year shall run from the first day of July until the last day of June.

Proposed Change: The membership year shall run concurrently with AERA membership. SIG members are to renew their membership at the same time they renew AERA memberships. If a SIG member is not affiliated with AERA, then the membership year shall run from July 1 to June 30. Rationale: This makes the by-law consistent with the new AERA policy of joining a SIG when renewing memberships. It also clarifies the membership cycle for non-AERA members and renewing memberships.

Article IV: Elected Officials

<u>Section 2</u>. Every two years the President shall automatically become the immediate Past President, the President-Elect the President, and Vice President shall become the President-Elect. **Proposed Change:** Every two years the President shall automatically become the Immediate Past President, the President-Elect assumes the office of President, and the Vice President shall become the President-Elect/Program Chair. **Rationale:** Clarifies the language of the previous by-law.

<u>Section 3</u>. All officers shall hold office for two years. <u>Proposed Change</u>: SIG officers must retain both SIG and AERA membership. Failure to do so will make the officer ineligible to hold the office. <u>Rationale</u>: This makes this section consistent with changes to Article III, Section 1.

<u>Section 4</u>. The term of office shall be from the closing of the annual meeting of AERA through the next annual meeting. **Proposed Change:** The term of office shall start at the closing of the annual meeting of AERA and continue for two years. **Rationale:** This makes this section consistent with the previous changes for the two-year terms of office.

<u>Section 5</u>. Only members whose dues are paid may be nominated and hold elective office. **Proposed Change:**Only members whose AERA and SIG dues are paid may be nominated and hold elective office. **Rationale:** This proposed change would make this section consistent with previous proposed section changes that require an officer to be a member of AERA and the SIG simultaneously.

Article V: Nominations and Elections

<u>Section 2</u>. The Nominating Committee will consist of the President-Elect, the President, and the Past President. The current President will serve as chair of the committee. **Proposed Change**: The Nominating Committee will consist of the President-Elect, the President, and the Immediate Past President. The current President will serve as chair of the committee. **Rationale**: Clarifies the language of the by-law.

Article VII: The SIG Association Council

<u>Section 1</u>. The SIG Association Council shall be made up of the Executive Committee and seven members of the organization who are to be elected in the same manner as the officers. **Proposed Change**: Council members must be current with both AERA and SIG membership dues. **Rationale**: This would make expectations for SIG Officers and Council members consistent. Supports leadership and SIG membership in AERA.

Article VIII: Committees

The Membership Committee will consist of one Association Counselor from each state and country represented on the Council and such persons the President-Elect appoints. Proposed Change: The Membership Committee will consist of one Association Counselor from each sate and country represented on the Council and such persons the President or President-Elect appoints. Rationals: Allows both the President and President-Elect to appoint members to the Membership Committee.

Proposed changes to the SIG: RMLE By-Laws submitted by the President and President-Elect for discussion by the membership at the SIG RMLE Business Meting on April 4, 2002, AERA Annual Meeting, New Orleans. A complete copy of the SIG RMLE By-Laws may be viewed at the SIG website: www.rmle.pdx.edu
